COVID-19 Contact Tracing

During the Covid pandemic how we must run things is a little different, only for your safety and the safety of the children and staff within our setting. We need you to be forthcoming, especially if you come in contact with or have anyone in your family who have developed symptoms. We rely on you to keep your child home to prevent any further spreading, until such time you or your family member is tested. You will also need to let our setting know asap, so we can report to Track & Trace, who will then give us further guidelines.

- ♣ Please, if you or your child is unwell, has a temperature and/or is displaying any symptoms, please keep them home and notify our setting asap.
- ♣ We will take childrens temperatures so please do not give your child medicine for a temperature before sending them to club, because as soon as it wears off, they may then start to display symptoms. If this happens, we will have to keep your child in a quiet room with a trusted experienced staff member until such time you can come and collect them. We will then follow our guidelines and call the Covid 19 helpline and track and trace. Thank you for cooperation.
- ♣ If a positive case is confirmed by PCR test result Contact tracing will contact us, who then gathers information and informs them of known direct contacts (within 2 metres for 15 minutes or more) within the setting and the type of interactions. We will be asked to provide the child's name, date of birth and telephone numbers. This is in accordance with the below government privacy notice:

IMPORTANT INFORMATION!

We are doing our best to provide a service. So as not to take away from the childrens experiences and relaxed play time, we have therefore decided to run on lower numbers, so essentially, we have only ONE bubble of children.

With that in mind: Should anyone, a staff member or child become unwell or start to display symptoms, this can have a huge impact on the whole setting. It means should a child or adult become unwell, that our whole setting may need to self-isolate. So please keep your child home should you or they feel unwell, or anyone in your family, even if your child is not displaying symptoms.

Booking & Payment Terms

- 1. We cannot secure a booking without a booking form and payment of deposit.
- 2. No refunds will be given for absence due to illness.
- 3. We need two weeks (14 days) cancellation or change notice should you need to cancel or change days booked in with us.
- 4. No refunds will be given for a date or time change, within the agreed cancellation notice period.
- 5. We do reserve the right to cancel a child's place, in the event of non-payment.

Health & Safety

- 1. All areas and outings are safety checked and risk assessed at the start of each day. All staff are fire safety trained, meeting points and emergency procedures are clearly displayed.
- 2. A detailed register will be completed for each child. This ensures that all staff are fully aware of any special health or educational needs.
- 3. A qualified first aider and a fully stocked first aid box will be always available, at all times.
- 4. All our equipment is regularly checked and logged.

Child Protection Procedures

- 1. All of our staff have the relevant qualifications and been given police clearance to work with children.
- 2. Each day all parents/guardians will be required to sign our sign in book, to ensure that children are only collected by themselves or a nominated adult
- 3. No other adults apart from, staff and checked persons will be allowed within the nursery.
- 4. We reserve the right not to accept any child who we think is not well enough to be at nursery.
